Terms and Conditions of Membership

The CDPC membership year runs from 1st January to 31st December.

- The Annual subscription is £10.00, £5.00 if joining after 1 July. If joining during the months of November and December you pay the annual subscription that will include the following year
- The CDPC court fee is normally £5 per attendance at any time. Should this differ at any session, players will be notified beforehand. This figure may be adjusted at any time without notice.
 1. Members may bring guests to play. Guests will be required to pay the normal court fee.
 2. New players may play two times before they are expected to join the Club and pay their annual subscription.
 3. The court must be pre-booked and the requisite number of fees paid in advance to obtain the key code to gain entry. Download the SPOND App .
 4. The net must be put away after each session unless there is a booking immediately after you finish. The paddles and balls as well.
 5. Follow the Hall's procedures for exiting and locking up. CCTV is in place to monitor this.
 6. Rules. The only local rule in place concerns hitting an obstruction above the court – if this occurs , play a let in all cases.
 7. Balls and paddles may be bought
 8. Information provided by members will be used only for the general purposes and operation of CDPC, including the provision of information to members by email and post. The Crondall Dinkers Pickleball Club (CDPC) are committed to protecting and respecting your privacy. Why we need your Data
